REPORT OF JAPAN TRUST FUND STEERING COMMITTEE MEETING 8 August 2013

WCPFC-SC9-2013/ RP-JTF-02

Introduction

The Steering Committee (SC) meeting of the Japan Trust Fund (JTF) was held on Thursday 8th August 2013, during the meeting of the Ninth Scientific Committee (SC9); it was chaired and convened by Professor Glenn Hurry, and supported by the new JTF Coordinator Dr Yujiro Akatsuka, JTF Administrator Tony Beeching (Secretariat), Country Representative Kathleen Sisior (Palau) and Pamela Maru Fisheries Forum Agency (FFA). The SPC SC representative was absent.

This was the second SC meeting in support of the second phase of JTF funding, which has greater emphasis on monitoring and compliance than the first phase. Funding is approved for the 5 years of the project, but there is competition for each annual budget. Total funding available for 2013 amounted to \$403,380, which was all allocated and disbursed in support of six projects.

1) Review of the project performance

Beneficiaries presented briefly on the 2013 projects (6), and on 3 further projects carried over from earlier funding tranches. Only one beneficiary, Indonesia was absent; this was due to their non-attendance at SC9. The Steering Committee provides a venue to air project issues and to resolve them.

Most projects have been successfully completed and reported on, however the following issues were raised:

- 1. Rhea Moss-Christian (NORMA) presented on work done to date on the project co-proposed by FSM and RMI, "Development of an Integrated Fisheries Information System in the Republic of the Marshall Islands and the Federated States of Micronesia." Whilst good progress had been made, the loss of the principal consultant/coordinator, Mr Colin Brown, who passed away earlier this year, has left a major gap in project.
 - The Steering Committee agreed to a hiatus to allow time for the project managers to revise their project plan and identify a replacement for the principal consultant.
 - The Steering Committee Chair agreed to meet with the project managers after SC9, to determine how best to move forward.
 - A revised project plan should be submitted to the JTF Administrator.
- 2. SPC Project "Introductory Training Workshop on Observer Data Reporting Tools" has been delayed by the departure of the project lead, Corey Cole. A replacement has been recruited with the anticipation that he will complete the project within the first 6 months of 2014, subject to the agreement of the JTF Steering Committee.
 - The proposed rescheduling of the delivery on this project was accepted.
- 3. Martin Finau described the ongoing Tongan JTF project "Support for the collection and the improved management of commercial tuna data in Tonga as well as providing awareness on conservation and management of tuna" Sampling officers' pay is based on an old pay scale and a per vessel basis, which may have been appropriate for small domestic vessels in the past; the samplers' current workload is greatly increased when working on large foreign fishing vessels, which are becoming increasingly prevalent in Tonga.

• The JTF Steering Committee agreed a revised proposal in which the pay rates for port samplers is increased from 12 pa'anga (sampler) and 8 pa'anga (assistant sampler) to 25 pa'anga per person per vessel sampled. This change in salary will be applied retrospectively for this calendar year (2013) and will not affect the JTF component of the budget (\$US 8,503).

2) Other Issues

The JTF call for 2014 project proposals will likely be made at the WCPFC TCC meeting in September, with a probable deadline for submission on or before 31 December 2013.
