Covers a wide range of agencies active in the Pacific region – official bilateral agencies, international governmental organisations, UN agencies and a variety of non-governmental organisations.

Coverage includes charities, trusts, foundations and official bodies offering assistance in Commonwealth countries in Asia and the South Pacific.

Covers organisations in a wide range of functional areas – funding agencies, information exchange and agencies covering research, development assistance and education and training.

Contains information on NGO organisations whose hallmark is the 'informal' implementation of small-scale projects entailing a large degree of local participation. The first volume contains descriptive profiles of the NGOs and the second volume a comprehensive series of descriptor lists and indexes.

Aimed at providing staff of the Fund with a brief guide to regional economic organisations, intergovernmental commodity organisations, and to intergovernmental development organisations other than those administered by FAO or UNCTAD. Covers Africa, Asia, the Middle East, the Pacific, Europe and the Western Hemisphere.
