SUBJECT THE 3RD PACIFIC STATISTICS STANDING COMMITTEE (PSSC) VIRTUAL MEETING, SPC – 25TH

NOVEMBER 2020

1. The Pacific Community (SPC) wishes to advise members that it will convene the 3rd PSSC Virtual Meeting on 25 November 2020

OBJECTIVES OF THE MEETING

 PSSC was established by the 3rd Regional Conference of Heads of Planning and Statistics at its meeting in July 2010 with his ToR reviewed at HOPS 2013. Its main purpose is to oversee the implementation of the <u>Ten-Year</u> <u>Pacific Statistics Strategy 2010 - 2020.</u>

MEMBERS AND COMPOSITION OF DELEGATION

- 3. Elected PSSC members are Government Statisticians (or a senior representative) of Australia, Cook Is, Fiji, Guam, Tonga, Nauru, New Zealand, Tokelau and Vanuatu. Cook Is and Tonga represent the Polynesia sub-region. The Melanesia sub-region is represented by Fiji and Vanuatu; and the Micronesia sub-region is represented by Guam and Nauru. Tokelau represents smaller National Statistics Offices.
- 4. ABS and Statistics NZ, the two advanced National Statistics Offices in our region, have generously and willingly supported PSSC since its establishment in 2013, and are members of PSSC.

OBSERVERS MEMBERS

- 5. In line with SPC-organised meetings' structure, representatives of donors and development partners currently supporting the Ten-Year Pacific Statistics Strategy (TYPSS) are also invited to attend PSSC Meeting as observers.
- 6. Currently, DFAT and MFAT are invited as the two main funding partners of TYPSS. In addition, ADB, PFTAC, PIFS, USP, UNICEF, UNFPA and World Bank are invited as main development collaborates working under the Regional Statistics Partnership Program.
- 7. Government Statisticians from other Pacific Countries and Territories including the staff members of the Statistics for Development Division have been exceptionally invited to attend to the meeting as Observers.

8. Observers are welcome to participate in the 3rd PSSC virtual meeting and should follow the nomination for registration procedure (see below). However, if the capacity limit for the online meeting is reached, members will be given priority for participation.

VIRTUAL PLATFORM - 3rd PSSC

- 9. Due to the impacts of COVID-19 on global travel and to comply with national restrictions, the decision was taken to host the 3rd PSSC meeting using a virtual platform.

- 11. The Meeting will be held virtually from 09:30 am to 2:00 PM Noumea Time
