Monitoring development progress, from MDGs to SDGs: the "good news"

- MDG Platform successfully established
- National collections -> Regional MDG database/regional Reporting (PIFS) -> Global reporting (feeding into UN specialist agencies + UNSD Global MDG database
- From that experience, should augur well for developing/maintaining SDG Platform t

Monitoring development progress, from MDGs to SDGs: the "not so good news"

- SDG platform development, on the basis of where things are at the moment: will be near impossible
- From MDGs -> SDGs: daunting monitoring challenge

Framework	Goals	Targets	Indicators
MDG	8	18	60
SDG	17	169	320+

- Even with the best will PSIDS (and most other developing countries) will not be able monitor 320 indicators let alone collect the underlying statistics
- 3 compelling reasons:
 - Most of the data for new goals/targets and associated indicators are not yet collected (at least not on a regular basis)
 - Between 2000 2015 (MDG period), most PSIDS have not been able to conduct a census with their own budget, and no PSIDS has been able to undertake a HIES/DHS without external finance
 - Given current financial climate, NSO domestic budgets + international development support remaining at current status as likely best-case scenario, situation looks grim.

Monitoring development progress, from MDGs to SDGs: "a manageable scenario"

- Accept/embrace the total number of SDGs = 17 (untouchable)
- Accept/embrace reality, that 169 Targets and indicators are unworkable (Both from a global development financing support for implementation, as well as regards regular monitoring)
- Agree on a limited set of targets/associated headline indicators (between 2 4) all countries can commit to for global monitoring.
 <u>Caveat</u>: this should not, however, "allow" countries (political/regional groupings) to opt out of the difficult challenges.
- This is something, that some members of the SDG Inter-Agency Expert Group on indicators will raise at its inaugural first working group meeting 1 2 June: to review the feasibility of coming up with a shortened set of a limited number (2 4) of headline indicators for all SDGs.
- Preliminary attempts at prioritizing from a strictly technical/professional angle of what targets/associated indicators are most feasible, suitable and relevant, involving key technical divisions at SPC, Forum Secretariat and SPREP, as well as some interdisciplinary/agency working groups (CC-DRM; NCDs-Food Security; Marine Sector Working Group, involving SPC, SPREP, FFA, PIFS), came up with a first cut of 62 target/indicator combinations.
