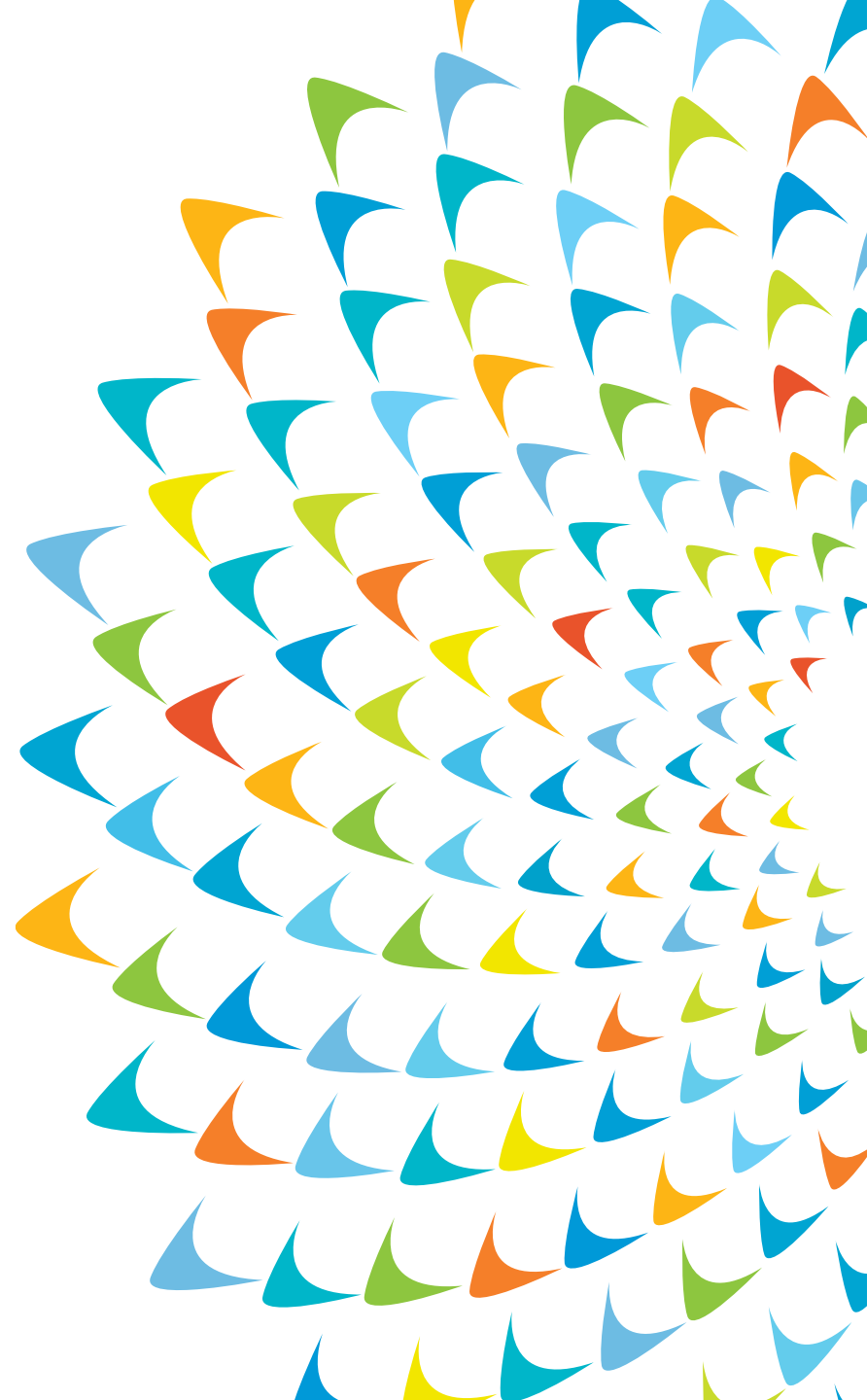

KSTA 6565 Overview

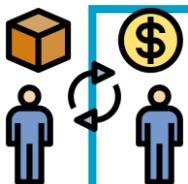
- **Objectives:**
 - Utilize all available and accessible survey, administrative, and innovative data; and
 - Employ advanced statistical methods to produce the principal components of a System of National Accounts (SNA)
- **Intended impact:** advancement of the national statistical systems through statistical capacity building initiatives
- **Expected outcome:** NSSs to produce highly relevant, accurate, timely, and detailed statistics on selected economic domains
- **Participating countries:**
 - Pacific Island Countries: Cook Islands, the Federated States of Micronesia, Kiribati, the Marshall Islands, Nauru, Niue, Palau, Samoa, the Solomon Islands, Tonga, Tuvalu, Vanuatu
 - Southeast Asia: Timor-Leste
 - Central and West Asia: Afghanistan



KSTA 6565 Proposed domains



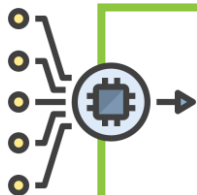
Functional statistical business registers established in developing member countries



Detailed supply-use tables and input-output tables produced annually by the developing member countries



Consistency of BOP statistics with national accounts



Utilize big data for statistical compilation



Data dissemination and knowledge sharing



KSTA 6565 Proposed detailed activities

- Conduct training on supply and use table (SUT), input-output table (IOT), basic input–output analysis, use of big data
- Construct and release current and constant price supply and use tables
- Deliver online SNA and statistical business register courses
- Integrate IOT into the ADB Multiregional Input-Output Database
- Establish Statistical Business Register
- Conduct regional workshop and knowledge dissemination activities



KSTA 6565 Progress



October 2020 – February 2021:
Received letters of no objection

March – May 2021: Conducted meetings with statistics offices, SPC, PFTAC, and Graduate School USA



April – June 2021: Received data assessment questionnaire from statistics offices
(Pending: KIR, NAU)

April – present: Coordinating with statistics offices on capacity building priorities



May 2021 - Present: Conducted online training on Statistical Business Register for VAN

Conducted workshops on System of National Accounts (SNA), Supply and Use Table Framework for VAN, TUV*, TIM, PAL*

Oct 2021-March 2022: Conduct Online workshops/ trainings on SNA, SUT, and SBR for SAM*, RMI*, FSM, SOL
