

## STATEMENT DELIVERED BY THE HONOURABLE MINISTER FOR FISHERIES 1<sup>st</sup> REGIONAL FISHERIES MINISTER'S MEETING 26 August 2020 SUVA, FIJI

## Salutation

The Honourable Chair, Honourable Prime Minister Puna, Honourable Ministers, Representatives from our CROP agencies

Ladies and Gentlemen,

Honourable Chair,

May I first join others in congratulating you on your role as chairman. Today we come together to mark a new chapter of strengthening regional cooperation, solidarity and friendship through this inaugural session, and especially in these unprecedented times.

While each of our countries has our own unique challenges, we as a region like the rest of world have all been greatly affected by the impacts of COVID-19.

Now more than ever does regional cooperation, solidarity and friendship play an important role.

Our economies that have plummeted, heath and security systems tested, threats to the fall of social structures as a result of mass job losses and the associated struggles faced on a daily basis.

- Add to the economic gains received through access agreements
- ensure full utilization of processing plants and provide employment opportunities across the region
- encourage domestication of fleets
- Fully utilize fish caught or cultured within the Blue Pacific Continent otherwise transshipped, landed at foreign ports, or exported as unprocessed commodities; and
- Maintain premium fish prices at the global level

We also reiterate the call for CROP agencies to work together in a more coordinated and concerted manner that is more efficient and effective to suit and address members' needs and aspirations.

Fiji remains committed to work with the CROP agencies and membership in making sure, we all achieve our obligations including the shared decision from our Leaders.

Honourable Chair, underpinning Fiji's global commitments, we are determined to support the regional efforts in sustainably managing the region's fisheries resources.

Honourable Chair, some key issues, which we hope to advance, includes;

- maritime boundary negotiations
- removal of harmful fisheries subsidies
- climate change threats
- response to COVID-19
- progressing on coastal fisheries, aquaculture and the road map for the longline fisheries,
- progress work on new, safe and innovative monitoring tools such as electronic monitoring

Honourable Chair in concluding, I would like to urge my fellow Ministers that the COVID pandemic would call us to make hard decisions. Decisions that determines the survival of our economy and its people. In due respect of the decision we make, we should all be reminded of our roles.

We owe it to our people to make the best decisions for their sustenance.
